# MINUTES OF THE ENVIRONMENT & WELLBEING COMMITTEE WEDNESDAY 18th SEPTEMBR 2019 AT 7.00pm, IN THE NEW SEACOURT HALL, 2nd FLOOR GRANT THORNTON BUILDING, BOTLEY.

1. APOLOGIES FOR ABSENCE.

3. MINUTES OF THE PREVIOUS MEETING AS CIRCULATED.

4. MATTERS ARISING

5. REPORT ON THE Botley Environmental Meeting held 6/9

Councillor Church gave the Committee a verbal update and undertook to write a full report for publication in The Sprout.

6. NEIGHBOURHOOD PLAN UPDATE

Councillor Kay informed the Committee that the Vale of White Horse District Council had agreed to make changes to some aspects Of the plan but not to the environmental section. The working Group were seeking independent advice.

7. OXFORD TO CAMBRIDGE EXPRESSWAY – DEVELOPMENTS

Councillor Kay reported that it was proposed to hold a public meeting jointly with Cumnor at Seacourt Hall in in November. A range of speakers was discussed which Councillor Church undertook to take forward.

#### 8. AIR POLLUTION

a. Botley school developments

Councillor Church reported that Oxfordshire County Council was taking the funding application forward for a green wall alongside the Botley School /A34 boundary in an effort to reduce air pollution.

b. Discussion with Vale

Councillor Church reported that he was to have discussions with The Vale of White Horse District Council about air pollution and climate change issues and would report back to the next meeting. He AGREED to discuss the possibility of funding and promoting a traffic anti idling campaign in Botley and Councillor Berrett AGREED to discuss with Councillor Jones possible involvement with Botley School.

c. Ox Air update

Councillor Church reported that Ox air were willing to attend a future meeting and discuss doing live pollution monitoring in Botley

#### 10 BOTLEY TO EYNSHAM CYCLEWAY UPDATE

The Committee noted that Oxfordshire County Council (OCC) was supporting this initiative.

#### 11 OXFORDSHIRE COUNTY COUNCIL CONSULTATION ON TRAFFIC MANAGEMENT IN OXFORD

The Committee noted that the OCC was consulting on the introduction of a £600 per parking space levy, bus gates and new bus services linking Witney, the JR and Abingdon. Councillor Church undertook to provide full Council with a briefing and Councillor Berrett undertook to publicise the OCC consultation on the NHPC web site.

#### 12 CLIMATE COMMUNICATIONS

The Committee AGREED to Councillor Church drafting a range of Climate Change Communications with the help of Councillor Berrett who also AGREED to create a climate action page for the NHPC web site.

Councillor Church AGREED to write to The Vale of White Horse DC requesting information on the number of items placed in recycling bins that was rejected as compared to other similar councils.

# 13 BOTLEY GREEN DAY

Councillor Church informed the Committee that the date had been moved to the 22<sup>nd</sup> Feb 2020 The Committee AGREED that Councillor Church should draw up a draft programme for the day along with a template invitation to and a list of organisations who could attend. The Committee also AGREED to set up a working party to firm up on details for the day.

#### 14 VERTICAL GARDEN/LIVING WALL UNDER A34 FLYOVER

Councillor Church reported as to way the vertical wall was not possible and how conversations with the Highways Agency had led to the Botley School application for environmental greening project funding along the School A34 boundary.

The Committee AGREED that Councillor Church should discuss: Vale Climate action plans, air pollution and as previously referred to; the proposed anti idling campaign.
