OXFORDSHIRE COUNTY COUNCIL (CUMNOR AND NORTH HINKSEY PARISHES) (SPEED LIMITS) ORDER 202*

The Oxfordshire County Council, in exercise of its powers under Section 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to that Act, hereby make the following Order.

- 1. This Order may be cited as the Oxfordshire County Council (Cumnor Parish) (Speed Limits) Order 202* and shall come into force on the day of 202*.
- 2. No person shall drive any vehicle at a speed in excess of 20 miles per hour in any of the lengths of road specified in Schedule 1 to this Order.
- 3. No person shall drive any vehicle at a speed in excess of 30 miles per hour in any of the lengths of road specified in Schedule 2 to this Order.
- 4. No person shall drive any vehicle at a speed exceeding 40 miles per hour in any of the lengths of road specified in Schedule 3 to this Order.
- 5. No person shall drive any vehicle at a speed exceeding 50 miles per hour in any of the lengths of road specified in Schedule 4 to this Order.
- 6. No speed limit imposed by this Order applies to a vehicle falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011, being a vehicle used for naval, military or air force purposes, when used in accordance with regulation 3(5) of those regulations.
- 7. The Oxfordshire County Council (Cumnor Parish) (Speed Limits) Order 2021 is hereby revoked/replaced.

20mph speed limit:

c)	B4044 Oxford Road (at Swinford Toll Bridge)	from a point 463 metres southeast of its junction with Wharf Road, southeastwards	for a distance of 236 metres.
d)	B4044 West Way (at Botley)	from its junction with Eynsham Road/Cumnor Hill, north-eastwards	to its junction with the A420 Botley Road.

e)	Cumnor Hill	from a point 87 metres southwest of its junction with Oxford Road, northeastwards	to its junction with the B4044 West Way, Botley.
f)	Oxford Road (at Cumnor)	from a point 105 metres east of its junction with Glebe Road, eastwards	to its junction with Cumnor Hill.
g)	A420 (at Botley)	from its junction with the B4044 West Way, northwards	for a distance of 40 metres.

c)	B4044 Oxford Road (at Farmoor)	from a point 515 metres northwest of its junction with Mayfield Road, north- westwards	for a distance of 490 metres.
d)	Cumnor Hill	from a point 72 metres northeast of the junction with the A420 southbound exit slip-road	to its junction with the B4017.
e)	A420 northbound on- slip (at Cumnor)	from its junction with the B4017 Abingdon Road, northwards	for a distance of 60 metres.

SCHEDULE 4

50mph speed limit:

a)	B4044 Eynsham Road (Dean Court)	From a point 52 metres west of its junction with Nobles Lane, north-westwards	to a point 96 metres southeast of its junction with the B4017 Cumnor Road, Farmoor.
b)	B4044 Oxford Road (at Farmoor)	From a point 1005 metres northwest if its junction with Mayfield Road, Farmoor, north-westwards	to a point 699 metres southeast of its junction with Wharf Road, Swinford.
